Spiral Production House Pvt. Ltd. recognises the importance of maintaining your privacy. This Privacy Policy is a legally binding document between you and Spiral Production wherein “You” shall mean any Vendor or User or Visitor visiting, using or registering with us and “Spiral Production House Pvt. Ltd.” and/or “We” shall mean all websites including <http://motionfilm.co/> ("Website") and/or any other medium in which we may provide services and is owned and managed by Spiral Production House Pvt. Ltd., a Private Limited Company registered under The Companies Act, 2013, having its registered office at...

This Policy describes how we treat user information we collect on our websites and other offline sources. This Privacy Policy applies to current and former visitors and to users. By visiting and/or using Spiral Production (website) you agree to this Privacy Policy.

This privacy policy is subject to the Terms of Use (User agreement) of Spiral Production Platforms. This policy is effective from the date and time a User registers with or visits Spiral Production Platforms or by filling up the Registration form and/or accepting the Terms of Use laid out in the Policy.

1. Collection of Information

Identifiable Information. When you use Spiral Production website, we collect your name, email, mobile number, Aadhar Card, Pan card, Bank Details, phone number, street, city, state, pin-code, country and IP address. We may collect demographic information about the Users or the Visitors.

Payment Information. We might collect your billing name, billing address and payment method when you subscribe to Spiral Production services. We may also collect your credit card number or debit card number or their expiry date or bank account details or other details pertaining to your payment method accepted by you on our payment gateway at Spiral Production websites. Credit card information will be obtained and processed by our online payment partner _____.

Posted Information. We may collect information you post in a public space or through registration form available on Spiral Production website. You can choose not to provide certain information but then you might not be able to take advantage of many of our features. We use the information that you provide for such purposes as responding to your requests, customising future services for you, improving our platform, and communicating with you.

Automatic Information. We may collect information about your IP address and the browser you're using. We might look at what site you came from, duration of time spent on our website, pages accessed or what site you visit when you leave us. We might also collect the type of mobile device you are using, or the version of the operating system your computer or device is running.

2. Controllers of Personal Information. Any personal information provided to or gathered by Spiral Production services under this Privacy Policy will be stored and controlled by Spiral Production House Pvt. Ltd. (the data controller) on servers bought or taken on rent.

3. Ways to Collect Information

Direct Information. The information may be collected directly from you when you register with us as a User. We also collect information if you post a comment on our websites or ask us a question through phone or email.

Passive Information. The information may be collected through the use of tracking tools like Google Analytics, Google AdWords, Google webmaster, browser cookies and web beacons, SEO Tools for collecting information about your usage of our Spiral Production (Website and App)

Information from third parties. The information may be gathered from third party websites, social media, etc.

Cookies. We may use "cookies" and we obtain certain types of information when your Web browser accesses Spiral Production website or advertisements. The information may be used for internal analysis and to provide you with location-based services, such as advertising, search results, and other personalized content.

4. Use of your Information

Transactional Communications. The information provided by you will be used to contact you for confirmation of a subscription of our product/services. We might send you emails or SMS about your account balance and referrals made by you in case of a Registered User.

Responding to requests or questions. The information may be used to confirm any queries, complaints, suggestions or demands made by you on our website.

Security purposes. The information may be used to protect our company, our users, or Spiral Production services.

Marketing purposes. We might send you information about special promotions or offers or referral policies. These might be our own offers or products, or third-party offers or products we think you might find interesting.

Legal Use. The information shall be used as otherwise permitted by law.

Deleting data. If your data is no longer required for the purposes mentioned or if their storage is inadmissible for other legal reasons, we will delete them. However, the exception to this would be any lawfully collected data which we are obliged to keep for legal reasons.

Also please note that for every deletion the data are initially only blocked and finally deleted with a time delay in order to prevent accidental deletions or possibly intentional damage. For technical reasons, data may be duplicated in backup files and mirroring services. Copies of the data will also be deleted, although there might be a technical delay.

5. Rights of Registered Users

Rights to object. You have the right with regard to your personal data to request information, correction, deletion or restriction in accordance with statutory provisions. We also provide you with your data in a structured, common and machine-readable format. If we use your information based on your consent, you may revoke your consent at any time and request the deletion of such information. After the revocation, we use your data no longer for this purpose. You have the right to object to the processing of your personal data, as far as there are reasons for this arising from your particular situation. In case of a legitimate objection, we will no longer process the personal data. |

6. Sharing of information with third-parties

Service vendors. The information may be shared with the vendors who help us in managing our online registration process or payment processors or transactional message processors.

Also, we share your information with the third party and to improve the application and for the benefits of the Registered User and the Users only to the extent permitted by law.

Business Partners and/or Successors. The information may be shared with the sponsors of our website/or app or business associates. The information shall be used by our business partners we give them as described in their privacy policies.

The information may also be shared with any legal successors of the business. For example, if our business is reconstructed in any manner, we may give our Registered User list as part of that transaction.

Comply with law. The information may be shared to respond to a court order or subpoena. We may also share it if a government agency or investigatory body requests or we might also share information when we are investigating potential fraud.

Reasons not described. The personal information provided by the Registered User/Users to Spiral Production website will not be provided to third parties without previous consent of the concerned party. Information of a general nature may however be revealed to external parties and shall be subject to User agreement.

7. Protection of Information

Every effort will be made to keep the information provided by users in a safe manner, the information displayed on the website and/app will be done so only after obtaining consent from the Registered User and/or Visitors. Any person browsing the site generally is not required to disclose his identity or provide any information about him/her, it is only at the time of registration you will be required to furnish the details in the registration form.
